



HALF MARATHON/8K October 8, 2017

The Ramblefest Half Marathon and 8K will take place on October 8, 2017.

Race start time will be 9:30 AM for the Half Marathon and 10 AM for the 8K

LIMITED TO FIRST 750 registered runners for the Half, and first 200 registered runners for the 8K.

Registration Fees for the Half Marathon are:

\$60.00* until May 21, 2017, \$70.00* from May 22 thru August 31, 2017, \$80.00* from September 1 thru October 6, 2017

*** NOTE: there is an additional \$4.00(1/2)/\$2.00(8K) online/credit card processing fee added to the registration fee.**

Registration Fees for the 8K are:

\$30 until May 21, 2017. , \$35.00 from May 22 thru August 31, 2017. \$40 from September 1-October 6, 2017

Race Packet Pick up will be at Berkshire Running Center, 34 Depot Street Pittsfield, MA 01201 on Friday October 6 from 10AM-6PM and Saturday October 7 from 10 AM until 5 PM. Day of race packet pick up will be at the Berkshire Mall from 7 AM-8:45 AM, and near the Church Street Trial Head from 9-9:45 AM. Please pick up early if possible!

Race proceeds will help fund a North County Non Profit Organization (TBD)

NO REFUNDS/DEFERMENTS you may transfer your registration to another runner, you may also switch down from the Half Marathon to the 8K (no refund for cost difference).
